8. By a vote of 3-0, approved the stipulation of settlement between the Division of Gaming Enforcement and Franklin D. Mauger, 3rd; and granted the application of Mr. Mauger, for an initial casino key employee license, subject to compliance with certain reporting conditions, as provided for in the stipulation (DKT-13-0012-CK) (Ruling number 13-08-08-08; transcript pages 18-21).

By a vote of 3-0, adjourned the petition of Harrah's Atlantic City Operating Company, LLC (*d/b/a* Harrah's Resort Atlantic City), for the issuance of a temporary casino key employee license to Ricky S. Mazer, pursuant to N.J.S.A. 5:12-89(e) and to permit him, pursuant to N.J.A.C. 13:69C-2.6 to assume the duties and exercise the powers of Senior Vice President and General Manager, pending plenary qualification (PRN 2131305) (transcript pages 21-22).


There being no members of the public to address the Commission, the meeting adjourned at 10:47 a.m.
