MINUTES - PUBLIC MEETING NO. 15-12-09 December 9, 2015 - 10:30 a.m.

New Jersey Casino Control Commission Joseph P. Lordi Public Meeting Room - First Floor Tennessee Avenue & Boardwalk Atlantic City, New Jersey

Subsequent to the reading of a statement of compliance with the notice requirements of the Open Public Meetings Act and identification of items discussed during closed session, the Commission considered and took formal action on the following matters:

Chairman Levinson, on behalf of the Commission, recognized retiring Robert Latimer, employee of the Division of Gaming Enforcement.

- 1. By a vote of 3-0, ratified the minutes of November 10, 2015 public meeting (transcript pages 7-8).
- 2. The Commission unanimously approved the 2016 Annual Meeting Schedule (ruling number 15-12-09-02; transcript pages 8-9).
- The Commission unanimously adopted Resolution No. 15-12-09-03 permitting the 3. Commission to hold a closed session before each scheduled public meeting in 2016 (ruling number 15-12-09-03; transcript pages 9-10).

- 4. By a vote of 3-0, granted the application of Lee A. Terfloth, for an initial casino key employee license (Exhibit EL-1*; transcript page 10); and
 - By a vote of 3-0, remanded the initial application of Jean M. West (a/k/a) Jean Marie McMahon) for a casino key employee license to a hearing (Exhibit EL-2*; transcript pages 10-12).
- 5. By a vote of 3-0, granted the resubmitted application of Robert J. Rupprecht for a casino key employee license (Exhibit EL-2*; transcript page 12).
- 6. Temporary casino key employee licenses were issued between November 6 and December 7, 2015, pursuant to Delegation of Authority Resolution Number 13-01-10-16-C to the following applicants: John M. Carr, Joseph M. Farnan, Jamie M. Harris, Steven Yanoff, Andrew G. Yap and Debra A. Holden (Exhibit EL-4*; transcript pages 12-13).
- 7. By a vote of 3-0, adopted the draft resolution and issued a temporary casino key employee license to Damian R. Taylor, pursuant to <u>N.J.S.A.</u> 5:12-89(b) 4 and <u>N.J.S.A.</u> 5:12-89(e); and permitted him to assume the duties and exercise the powers of Chief Information Security Officer for Golden Nugget, LLC, pending plenary qualification; subject to the conditions contained in <u>N.J.A.C.</u> 13:69C-2.7 (c) (PRN 3281502) (Ruling number 15-12-09-07; transcript pages 13-26).
- 8. By a vote of 3-0, granted the requested relief and inactivated the casino key employee licenses held by Albert J. Barrett, Anthony M. Pancari, Sr. and Wilbert Vincent, Jr. (Ruling number 15-12-09-08-A; 15-12-09-08-B; 15-12-09-08-C; transcript pages 26-28).
- 9. By a vote of 3-0, found that Robert J. Angelone, Alisa N. Corbitt, Theresa A. Gerhardt, Margaret A. Grafton, Stephanie M. Murphy, Joseph J. Pasterino and Gregory A. Robertson casino key employee licenses lapsed, pursuant to *N.J.A.C.* 19:41A-6.1 (f) (Ruling number 15-12-09-09-A; 15-12-09-09-B; 15-12-09-09-C; 15-12-09-09-B; 15-12-09-09-F; 15-12-09-09-F; 15-12-09-09-G; transcript pages 28-29).
- 10. By a vote of 3-0 suspended the credential held by Daniel S. Bowers. However, good cause was found to grant the requested relief and deferred this matter, pursuant to NJSA 5:12-86(d), and continued in effect the suspension, subject to the conditions in the Order (DKT 15-0014-RC) (ruling numbers 15-12-09-10; transcript pages 29-32).

- 11. By a vote of 3-0, adopted the draft resolution and found Andrew Langham, qualified to serve as General Counsel of Icahn Enterprises GP, Inc., in accordance with <u>N.J.S.A.</u> 5:12-85.1c, <u>N.J.S.A.</u> 5:12-85.1d, <u>N.J.S.A.</u> 5:12-89b(1), <u>N.J.S.A.</u> 5:12-89b(2) and <u>N.J.A.C.</u> 13:69C-2.7 (PRN 2581501) (Ruling number 15-12-09-11; transcript pages 32-35).
- 12. Considered the petition of Caesars Enterprise Services, Harrah's Atlantic City Operating Company, LLC, Boardwalk Regency Corporation and Bally's Park Place, Inc. and issued the following ruling:

By a vote of 3-0, approved the petition and issued a plenary casino key employee license to David Koloski, pursuant to *N.J.S.A.* 5:12-89(e), with a multi casino endorsement, pursuant to *N.J.S.A.* 5:12-91.1; and found Mr. Koloski qualified to serve as Vice President Marketing Operations VIP for Caesars Enterprise Services, Harrah's Atlantic City Operating Company, LLC, Boardwalk Regency Corporation and Bally's Park Place, Inc., in accordance with *N.J.S.A.* 5:12-85.1b; and *N.J.A.C.* 13:69C-2.6. Further, granted the petitioners' request to waive the residency requirement, as provided for in *N.J.S.A.* 5:12-89(b) 4 (PRN 0551502) (15-12-09-12; transcript pages 35-41).

In accordance with Resolution No. 15-12-09-03, the next closed session of the Commission shall be held on Wednesday, January 13, 2015 at 9:30 a.m. in the Commission Offices (transcript page 41).

There being no members of the public to address the Commission, the meeting adjourned at 11:02 a.m.
