Subsequent to the reading of a statement of compliance with the notice requirements of the Open Public Meetings Act and identification of items discussed during closed session, the Commission considered and took formal action on the following matters:

- 4. By a vote of 3-0, granted the requested relief and inactivated the casino key employee license held by Jerry Bear, Kathleen A. Cassidy, Lynette A. Holcomb, Linda M. Hughes-McCarthy, Stanley J. Kozlowski, Matthew D. Lowry, George F. Marks, Jr., Thomas W. Miller, Jean L. Preikszaitis, Louis J. Totoro and Harry R. Tracy (Ruling numbers 16-02-10-04-A, 16-02-10-04-B, 16-02-10-04-C, 16-02-10-04-D, 16-02-10-04-J, 16-02-10-04-F, 16-02-10-04-G, 16-02-10-04-H, 16-02-10-04-I, 16-02-10-04-J, 16-02-10-04-K; transcript pages 10-11).
- 5. By a vote of 3-0, found that Keir L. Anderson, Nicolas E. Kurban, Pamela R. Ramsey, Henry L. Reyes, Steven M. Sharp, Reyni M. Silverio and Michael L. Stafford casino key employee licenses lapsed, pursuant to *N.J.A.C.* 19:41A-6.1 (f) of the regulation (Ruling number 16-02-10-05-A; 16-02-10-05-B; 16-02-10-05-C, 16-02-10-05-D, 16-02-10-05-E, 16-02-10-05-F, 16-02-10-05-G; transcript pages 11-13).
- 6. Considered the Caesars Entertainment Corporation, Harrah's Atlantic City Operating Company, LLC, Bally's Park Place, Inc., Boardwalk Regency Corporation and Caesars Interactive Entertainment New Jersey, LLC and issued the following ruling:

By a vote of 3-0, adopted the draft resolution and authorized Leslie M. Ottolenghi, on a temporary basis and prior to her plenary qualification, to assume the duties and exercise the powers of Chief Information Officer for Caesars Entertainment Corporation, pending plenary qualification, subject to the conditions contained in *N.J.S.A.* 5:12-85.1 c and *N.J.A.C.* 13:69C-2.7 of the Act (PRN 0151601) (Ruling number 16-02-10-06; transcript pages 13-17).
