WHEREAS, the Division of Gaming Enforcement (Division) filed a letter report dated December 6, 2012, in which it recommended that the Commission permit Ms. Monzo to assume the duties and exercise the powers of that position before being qualified; and

WHEREAS, the Commission considered the entire record of the proceedings at its public meeting of December 12, 2012; and

NOW, THEREFORE, BE IT RESOLVED by the Commission that Darlene Monzo is temporarily qualified and is hereby authorized to assume the duties and exercise the powers of Senior Vice President of Marketing for Revel, subject

RESOLUTION OF THE NEW JERSEY CASINO CONTROL COMMISSION CONCERNING THE PETITION OF CAESARS ENTERTAINMENT CORPORATION, CAESARS ENTERTAINMENT OPERATING COMPANY, INC., SHOWBOAT ATLANTIC CITY OPERATING COMPANY, LLC, HARRAH'S ATLANTIC CITY OPERATING COMPANY, LLC, BALLY'S PARK PLACE, INC., AND BOARDWALK REGENCY CORPORATION REQUESTING AN EXTENSION OF TIME PURSUANT TO *N.J.A.C. 13:69C-2.7(d)(2)* (PRN 3401201)

WHEREAS, casino licensees Harrah's Atlantic City Operating Company, LLC (Harrah's), Showboat Atlantic City Operating Company, LLC (Showboat), Bally's Park Place, Inc., (Bally's) Boardwalk Regency Corporation (BRC) and their holding companies Caesars Entertainment Corporation (CEC) and Caesars Entertainment Operating Company, Inc. (CEOC) (collectively, "the Petitioners") filed PRN 3401102 on December 6, 2011, seeking permission for Thomas M. Jenkin to assume the duties and exercise the powers of President of Operations of CEC and CEOC prior to his plenary qualification; and

WHEREAS, on December 14, 2011, the Casino Control Commission (Commission) with the recommendation of the Division of Gaming Enforcement (Division) granted the requested ruling for a nine-month period in accordance with the conditions contained in *N.J.A.C. 13:69C-2.7* (Resolution No. 11-12-14-6); and

WHEREAS, Thomas M. Jenkin filed a Personal History Disclosure Form-MJ and NJ Supplement on December 19, 2011; and



WHEREAS, on August 8, 2012 the Commission granted the Petitioners' request for an extension of Mr. Jenkin's temporary qualification for 90 days, to December 12, 2012, to allow the Division to complete its investigation. Resolution No. 12-08-08-6; and

WHEREAS, the Division of Gaming Enforcement has indicated that it will not be able to complete its investigation and report to the Commission regarding Mr. Jenkin's plenary qualification prior to the expiration of temporary qualification on December 12, 2012; and

WHEREAS, Petitioners filed PRN 3401201 on December 5, 2012, seeking to establish good cause pursuant to *N.J.A.C. 13:69C-2.7(d)2* for a ruling extending Mr. Jenkin's temporary qualification period for an additional period of 30 days from December 12, 2012; and

WHEREAS, the Division does not object to the Commission granting the requested relief; and

WHEREAS, the Commission considered the matter at its public meeting of December 12, 2012;

NOW, THEREFORE, BE IT RESOLVED by the Commission that (a) good cause has been established pursuant to *N.J.A.C. 13:69C-2.7(d)2* to extend the period of temporary qualification of Thomas M. Jenkin; and (b) Thomas M. Jenkin is hereby authorized to continue to perform the duties and exercise the powers of President of Operations for CEC and CEOC pending plenary
