



(Borgata), for the exclusive purpose of considering the continued qualification of MGM Resorts International, f/k/a MGM MIRAGE, (MGM), as a holding company of Borgata, in light of the issues raised in the Special Report of the Division of Gaming Enforcement to the Casino Control Commission on its investigation of MGM MIRAGE's Joint Venture with Pansy Ho in Macau, Special Administrative Region, People's Republic of China (Special Report) (See, Resolution No. 09-09-22-13); and

WHEREAS, on March 11, 2010, MGM, the Division of Gaming Enforcement (Division) and Borgata (for itself and its holding companies Marina District Development Holding Co., L.L.C. (MDDH), Boyd Atlantic City, Inc. and Boyd Gaming Corporation (Boyd) executed a Stipulation of Settlement (the Stipulation) and agreed to the form of a Trust Agreement (the Trust Agreement) to create and govern the terms of a divestiture trust (the Trust) to dispose of MGM's entire indirect ownership interest in the casino license of MDDC, the



owner and operator of Borgata Hotel Casino and Spa, and certain real property and ground leases related thereto (collectively, the Trust Property) by which they proposed to resolve and conclude Borgata's reopened 2005 casino license renewal hearing and through PRN 0701003, filed with the Commission on March 11, 2010, MGM, Boyd and MDDH sought approval of the Stipulation and Trust Agreement; and

WHEREAS, on March 17, 2010, the Commission approved the Stipulation and form of the Trust Agreement based upon and to the extent set forth in the findings and rulings, and subject to the conditions contained in the Resolution (See, Resolution No. 10-03-17-10); and

WHEREAS, on August 8, 2011, the Commission approved a First Amendment to the Stipulation and a First Amendment to the Trust Agreement, whereby the Divestiture Period was extended for an 18 month period terminating on March 24, 2013 and the Terminal Sale Period commencing on March 24, 2013 and terminating on March 24, 2014; and

WHEREAS, on February 13, 2013, the commission approved a Second Amendment to the Stipulation and a Second Amendment to the Trust Agreement, whereby the application bar contained in the Stipulation of Settlement was waived to allow for the filing of a petition for a Statement of Compliance and related relief and the running of time of the Divestiture Period and the Terminal



Sale Period was tolled until Commission action on the petition for a Statement of Compliance; and

WHEREAS, on September 25, 2013, MGM, Boyd and Borgata filed Joint PRN 2681306 for approval of an amendment to the Surface Parking Lot Lease (Block 576, Lot 1.07) between Marina District Development Company, LLC and MAC CORP. as required by paragraph K of the Stipulation; and

WHEREAS, the Commission considered the matter at its public meeting on October 16, 2013;


