Farmer, Jr. was found qualified by the Commission to serve as Trustee in accordance with the standards set forth in *N.J.S.A. 5:12-85.1a*, and the Commission further approved the Trust Agreement between CEI, Caesars Resort Collection, LLC ("CRC") and John J. Farmer, Jr., as Trustee (Commission Order No. 20-07-15-14); and

WHEREAS, the Trust Agreement provides, *inter alia*, that within twenty (20) days following the disposition of all Trust Property, the Trustee is required to prepare a final accounting and present same to the Caesars Parties and to the Division, and if satisfactory to the Division, then the Trustee must submit the final accounting along with a request to dissolve the Trust and discharge the Trustee to the Division for its approval; and

WHEREAS, the Trust Agreement further provides, *inter alia*, that after a determination by the Commission, based upon a recommendation by the Division, that the Caesars Parties have spent the entire required amount on improvements to its Atlantic City properties in accordance with the Trust

Agreement and the Trust property is no longer required, the Trustee shall be informed of the Commission determination and transfer all of the remaining interest earned on the principal of the Trust Property to the Caesars Parties; and

WHEREAS, CEI, Caesars AC, Harrah's AC and Trop AC having filed a Petition (PRN 0112402) dated January 11, 2024 seeking an Order from the Commission (1) approving the closure of the Trust Account with Truist Bank and the release all of the residual interest in the Trust Account to CEI; (2) terminating the Trust Agreement dated July 20, 2020 between CEI, CRC and John J. Farmer, Jr. as Trustee; and (3) discharging the Trustee, John J. Farmer, Jr. as the Trustee for the Trust Account; and

WHEREAS, the Division filed a Letter Report dated January 30, 2024 confirming that CEI complied with Conditions 25 and 26 of Commission Order 20-07-15-14 and the applicable terms of the Trust Agreement and recommending that the Commission grant the requested relief; and

WHEREAS, the Commission considered the entire record of the proceedings at its public meeting of February 14, 2024.

NOW, THEREFORE, BE IT RESOLVED by the Commission that the requested relief is hereby **GRANTED**.


IT IS FURTHER RESOLVED by the Commission that the Trust Account with Truist Bank shall be dissolved with any residual interest remaining in the


