Subsequent to the reading of a statement of compliance with the notice requirements of the Open Public Meetings Act and identification of items discussed during closed session, the Commission considered and took formal action on the following matters:

1. By a vote of 3-0, ratified the minutes of March 12, 2014 public meeting (transcript page 8-9).
2. By a vote of 3-0, granted the applications of Robert J. Mancinelli, Sonia D. Robinson-Ruffin, Naldi Santiago and Michael E. Tarud for casino key employee licenses (Exhibit EL-2\* transcript pages 9-10);

By a vote of 3-0, remanded the initial application of Edward J. Parkes, for a casino key employee license to a hearing (Exhibit EL-1\*;transcript pages 10-11);

By a vote of 3-0, remanded the initial application of Robert A. Stewart, for a casino key employee license to a hearing (Exhibit EL-1\*;transcript pages 11-12); and

By a vote of 3-0, remanded the initial application of Joseph L. Tortoreto, for a casino key employee license to a hearing (Exhibit EL-1\*;transcript pages 12-13).

3. By a vote of 3-0, granted the resubmitted applications of Kostadinka K. Banareva, Angela M. Bianchini , Joseph M. Bianchini, Jr., Valerie A. Bisset, Howard J. Davis, III, Apryl Donnelly, Jay T. Gandhi, Benjamin R. George, Lawrence H. Kelder, Anthony M. Limone, Jr., Joanne L. McKensie, Michael R. Osley, Joseph A. Pace, Jr., Rosanna Presti-Mascavage, Anthony Previti, Charleen R. Ripley, Stanley J. Silow, Jr. and Erica Volkmann for casino key employee licenses (Exhibit EL-2\* transcript pages 13-14); and

By a vote of 3-0, remanded the resubmitted application of Joshua D. Gomez, for a casino key employee license to a hearing (Exhibit EL-2\*; transcript pages 14-15).

4. Considered the applications for casino key employee licenses and for qualification and issued the following rulings:

By a vote of 3-0, granted the initial casino key employee license application of LuAnn Pappas and for qualification as Regional Vice President of VIP Marketing for Harrah's Atlantic City Operating Company, LLC; Bally's Park Place, Inc., Boardwalk Regency Corporation and Showboat Atlantic City Operating Company, LLC (Ruling number 14-04-09-04-a) (transcript pages 15-16);

By a vote of 3-0, granted the resubmitted casino key employee license application of Ralph V. D'Ambrosio and for qualification as Vice President Player Development for Trump Taj Mahal Associates, LLC (transcript page 16);

By a vote of 3-0, granted the resubmitted casino key employee license application of Alisa Elkis and for qualification as Vice President Casino Marketing for DGMB Casino, LLC (transcript page 17); and

By a vote of 3-0, adopted the draft resolution and granted the resubmitted casino key employee license application of Loretta M. Pickus and for qualification as Senior Vice President – Legal and General Counsel for Revel Entertainment Group, LLC (Ruling number 14-04-09-04-b) (transcript pages 17-18).

5. Temporary casino key employee licenses were issued between March 10, 2014 and April 7, 2014, pursuant to Delegation of Authority Resolution Number 13-01-10-16-C to the following applicants: Hector L. Garcia, Geoffrey Salinas, Hansford Seetaram, Jeffrey S. Tanner, Edward A. Taylor and Javon Q. White (Exhibit EL-4\*; transcript pages 18-19).
6. By a vote of 3-0, granted the requested relief and inactivated the casino key employee licenses held by Robert A. Barger, Ronald M. Baumann, Brian F. Block,

Zachary Bocelle, Alberto C. Collazo, Stephen E. Heise, Susan M. Lutzie, Robert P. McHale Jr., and Norman E. Seid (Ruling numbers 14-04-09-06-A; 14-04-09-06-B; 14-04-09-06-C; 14-04-09-06-D; 14-04-09-06-E; 14-04-09-06-F, 14-04-09-06-G, 14-04-09-06-H, 14-04-09-06-I; transcript pages 19-20).

7. The consideration of casino key employee license termination of Kew F. Lee was withdrawn from consideration.

By a vote of 3-0, approved the termination of the casino key employee licenses held by Winnie T. Kong, Alphonso J. Maiorani, Edward C. Matthew, Clifford F. Mitchell, Dominick F. Raimond, Robert P. Sands and Barbara K. Sima (Ruling numbers 14-04-09-07-A; 14-04-09-07-C; 14-04-09-07-D, 14-04-09-07-E, 14-04-09-07-F, 14-04-09-07-G, 14-04-09-07-H; transcript pages 20-22).

8. Considered the petition of Golden Nugget Atlantic City, LLC. (*d/b/a* Golden Nugget Hotel Casino), and issued the following ruling:

By a vote of 3-0, approved the second amended and restated petition and issued a temporary casino key employee license to Thomas Winter, and permitted him to assume the duties and exercise the powers of the Office of Vice President of Online Gaming for Golden Nugget, LLC, pending plenary qualification, subject to the conditions contained in N.J.S.A 5:12-89 (e); and N.J.A.C 13:69C-2.7 (c) (14-04-09-08; transcript pages 22-26).

9. By a vote of 3-0, approved the stipulation of settlement between the Division of Gaming Enforcement and Holima M. Lamin, Jr.; and granted the resubmitted application of Mr. Lamin, for a casino key employee license, subject to compliance with a wage execution consent agreement (DKT 14-0003-CR) (Ruling number 14-04-09-09; transcript pages 26-28).

10. By a vote of 3-0, approved the stipulation of settlement between the Division of Gaming Enforcement and Carolyn M. Rogers; and granted the resubmitted application of Ms. Rogers, for a casino key employee license, subject to compliance with certain financial and reporting conditions, as provided for in the stipulation (DKT 14-0002-CR) (Ruling number 14-04-09-10; transcript pages 28-30).

11. By a vote of 3-0, approved the stipulation of settlement between the Division of Gaming Enforcement and Brian D. Kohler, Sr.; and granted the initial application of Mr. Kohler, for a casino key employee license, subject to compliance with certain financial and reporting conditions, as provided for in the stipulation (DKT 14-0007-CK) (Ruling number 14-04-09-11; transcript pages 30-32).

12. Considered the resubmission application of Eric J. Moore, Jr., for a casino key employee license and issued the following ruling:  
  
By a vote of 3-0, found Eric J. Moore, Jr., disqualified; denied his resubmitted application for a casino key employee license; and revoked his casino employee license (DKT 14-0004-CR) (Ruling number 14-04-09-12; transcript pages 32-34).
13. By a vote of 3-0, approved the stipulation of settlement between the Division of Gaming Enforcement and Edward J. Parkes; and granted the initial application of Mr. Parkes, for a casino key employee license, subject to compliance with certain financial and reporting conditions, as provided for in the stipulation (DKT 14-0009-CK) (Ruling number 14-04-09-13; transcript pages 34-36).
14. By a vote of 3-0, approved the stipulation of settlement between the Division of Gaming Enforcement and Sueheidi A. Vega; and granted the initial application of Ms. Vega, for a casino key employee license, subject to compliance with certain financial and reporting conditions, as provided for in the stipulation (DKT 14-0008-CK) (Ruling number 14-04-09-14; transcript pages 36-38).
15. Adjourned the Petition for temporary qualification and certain other relief in connection with Rock Gaming Interactive, LLC (PRN 0911402) (transcript page 38).


There being no members of the public to address the Commission, the meeting adjourned at 10:49 a.m.
