12 submitted by letter request -- a request that  
13 the two-year post employment restriction  
14 imposed by NJSA 5:12-60B(2) be waived as to him  
15 in this instance. NJSA 5:12-60B(2) provides  
16 that the employment of a commission member  
17 other than a policy -- employee other than one  
18 holding a policy-making management position, if  
19 it's terminated as a result of a reduction in  
20 the workforce, then the employee may accept  
21 employment with a licensee registrant or  
22 applicant at any time upon application to and  
23 approval of the Commission upon a finding by  
24 the Commission that the employment will not

1 nor does it evidence a conflict of interest in  
2 fact.

3 Mr. Perry was RIF'd on April 29, 2011,  
4 pursuant to the changes to the Casino Control  
5 Act. I have reviewed his application for your  
6 approval. It does not indicate that his  
7 position with Revel Entertainment, which is  
8 proposed as a security supervisor would, in  
9 fact, conflict with his position at the  
10 Commission and would not evidence a conflict an  
11 interest of in fact.

12 If you approve Mr. Perry's position --  
13 petition, it would be subject to his licensure,  
14 pursuant to other provisions of the Act. And  
15 it would be as to this employment only. It  
16 does not waive any requirements that exist in  
17 the conflicts of law as well as the Code with  
18 respect to confidentiality throughout one's  
19 post employment.
