6 case process, went to the conferences, and
7 entered into a Stipulation of Settlement with
8 conditions.

9 It's now before you for your
10 consideration.

11 CHAIR LEVINSON: Thank you very much.

12 MR. BISCIEGLIA: Nothing further from
13 the Division.

14 CHAIR LEVINSON: Any questions for
15 Counsel?

16 Do I -- entertain a motion in this
17 matter?

18 VICE CHAIR HARRINGTON: Mr. Chairman, I
19 move that we approve the Stipulation of
20 Settlement between the Division and Applicant
21 and grant the application of Jeremy S. Edwards
22 for an initial casino key employee license
23 subject to compliance with certain financial
24 and reporting conditions as provided in the
25 stipulation.

1 ITEM NO. 12

2 CHAIR LEVINSON: Thank you.

3 Is there a second?

4 COMMISSIONER COOPER: I'll make the
5 second.

6 CHAIR LEVINSON: Any discussion?

7 (No response.)

8 CHAIR LEVINSON: All those in favor?

10 CHAIR LEVINSON: Opposed?

12 CHAIR LEVINSON: Motion carries.

13 MS. FAUNTLEROY: Item No. 12 is the
14 application for suspension in "State versus
15 James L. Curtis."

16 CHAIR LEVINSON: Thank you.

17 MS. PIMPINELLI: Chairman and
18 Commissioners, you have the Division's
19 Application for Suspension and Complaint for
20 Revocation.

21 I would just like to add that yesterday
22 Mr. Curtis came in and spoke with me in person.
23 He filed a hearing request form, and he is
24 asking that his matter be deferred pending
25 resolution of the criminal charges.

2 The Division has asked that Mr. Curtis'
3 casino key employee license be suspended
4 pending either a hearing or the resolution of
5 those charges.

6 CHAIR LEVINSON: Thank you very much.

7 Mr. Bisciegliia?

8 MR. BISCIEGLIA: Thank you,
9 Commissioners.

10 Following a May 15th, 2013, arrest for
11 promoting prostitution, hindering apprehension,
12 and obstruction of justice which all occurred
13 at the Trump Plaza Casino on May 22nd, 2013,
14 the Respondent was indicted in Atlantic County
15 for these -- those previous offenses. Once he
16 was indicted, the Division felt that a
17 suspension application was warranted and ask
18 that the same be granted.

19 Thank you.

20 CHAIR LEVINSON: Thank you very much.

21 Is Mr. Curtis here or a representative
22 for Mr. Curtis?

23 (No response.)

24 CHAIR LEVINSON: Seeing none,
25 Commissioners, do you have any questions for

15 (No response.)

16 CHAIR LEVINSON: All those in favor?

17 (Ayes.)

18 CHAIR LEVINSON: Opposed?

19 (No response.)

20 CHAIR LEVINSON: Motion carries.

21 Thank you. Thank you.

22 MS. FAUNTLEROY: The addendums to the
23 agenda, Item No. 13, application of Teresa C.
24 Moody-Butler for an initial casino key employee
25 license.

2 CHAIR LEVINSON: Thank you.

3 I'll entertain a motion in this matter.

4 VICE CHAIR HARRINGTON: Mr. Chairman, I
5 move that we remand for a hearing the initial
6 key -- casino key employee license application

8 CHAIR LEVINSON: Thank you.

9 Is there a second?

25 requesting permission for Fredrick J. Kleisner

2 add that I have reviewed the draft resolution.
3 It's been distributed by Commission staff, and
4 we find the terms of that resolution to be
5 acceptable, and we ask that you grant our
6 petition.

7 Thank you.

10 MR. ADAMS: Mr. Chair, you have our
11 letter report, and we do not oppose the entry

13 COMMISSIONER COOPER: Yes.

14 MS. FAUNTLEROY: Vice Chair Harrington?

15 VICE CHAIR HARRINGTON: Yes.

16 MS. FAUNTLEROY: Chairman Levinson?

17 CHAIR LEVINSON: Yes.

18 MS. FAUNTLEROY: Let the record reflect
19 that it was a unanimous vote.

20 CHAIR LEVINSON: Thank you.

21 MR. ADAMS: Thank you.

22 MR. MAGAZZU: Thanks.

23 CHAIR LEVINSON: Thank you.

24 MS. FAUNTLEROY: In accordance with
25 Resolution No. 12-12-12-03, the next closed

4 CHAIR LEVINSON: Thank you very much.

5 This is the public participation portion
6 of the meeting. Does anyone from the public
7 wish to be heard?

8 FROM THE FLOOR: Yes.

9 CHAIR LEVINSON: Hi. Please state your
10 name.

11 MS. LOVULLO: My name is Kathy Lovullo.

12 CHAIR LEVINSON: You can come forward.

13 MS. LOVULLO: Sorry.

14 CHAIR LEVINSON: That's okay.

15 MS. LOVULLO: I've never done this
16 before.

17 CHAIR LEVINSON: That's all right.
18 State your name, please.

19 MS. LOVULLO: My name is Kathy Lovullo.

20 I am a 25-year Caesars employee as a
21 cocktail server. I'm a member of Local 54 and
22 a shop steward, and I'm here representing my
23 fellow coworkers from Harrah's, Showboat, and
24 Bally's.

25 I'm here today to bring to your

1 PUBLIC - LOVULLO

2 attention the changes in my job duties that
3 could possibly affect the State of New Jersey
4 gaming and alcohol regulations.

5 When I was hired 25 years ago, the
6 company gave us an extensive training on
7 assessing whether it was okay for me to serve a
8 guest an alcoholic drink, whether I should slow
9 the frequency of the drinks or whether I should
10 stop serving the guest. Throughout the years,
11 the casino refreshed this training for all
12 employees who serve alcoholic drinks to their
13 guests.

14 The casino has changed ownership many
15 times. Never once did a new owner change the
16 responsibility of determining whether a guest
17 should be given an alcoholic beverage from the
18 cocktail server who delivers the drink for
19 another employee.

20 This program that we go through is
21 called the CARE Program. It is "Controlling
22 Alcohol Risk Effectively." The company has now
23 created a new position called the Ambassador -
24 slash - at some properties, Beverage on Demand.

25 I have two concerns with this concept.

1 PUBLIC - LOVULLO

2 The first is that Ambassador takes the guest
3 drink order and enters it into an iPad. The
4 drink order then surfaces on the bartender's
5 Micros system in the service bar where we pick
6 up the drinks. The guest's drink can be
7 delivered by either me or three other cocktail
8 servers working in that area/zone. I now have
9 to go against Caesars' training that I received
10 and rely on someone else. I will no longer be
11 able to evaluate for myself if the guest should
12 be served an alcoholic beverage.

13 In this class that we take, the CARE
14 Program, I like to remember it as green light,
15 yellow light, red light. Green light is my
16 first encounter with the customer for the first
17 time. A yellow light means that I have served
18 this customer more than once. And now I have
19 to start paying attention to their actions, eye
20 contact, the conversations that are going on at
21 the table, and how they're gambling. And the
22 red light is I get to make the judgment call to
23 stop serving the guest.

24 Alcohol laws of New Jersey states that
25 the casinos are not allowed to serve alcohol to

2 people who are under 21 or intoxicated. Are
3 strictly liable for patrons' behavior and are
4 subject to the dram shop lawsuits for injuries
5 sustaining from negligence in serving alcohol.
6 I serve the guest -- I serve the drinks to the
7 guests. I am the liable person according to
8 the New Jersey alcohol law. I am responsible
9 for determining whether the guest should be
10 served an alcoholic beverage or not. This
11 Ambassador concept and the Beverage on Demand
12 does not allow us to make that assessment.

13 Another example of this is I've never
14 even seen the customer when I'm running out the
15 drink. All I'm given is a location, a table,
16 slot machine, and a seat, an area. And I go up
17 there, and that might be my first encounter --
18 that is my first encounter with the customer
19 who might be intoxicated or might be somebody
20 that should have been slowed down. Now I have
21 the drink on my tray. The customer sees me.
22 So now I might be in some kind of altercation
23 because now I'm making the decision that this
24 customer cannot have a drink.

25 My other concern is that many casino

2 employees' standard of living could possibly be
3 lowered due to this Ambassador concept. When
4 gaming was allowed in Atlantic City, we were
5 promised that the casino jobs would boost
6 economic development because they would be good
7 jobs with good pay and good benefits. I fear
8 that this Ambassador concept will eventually
9 reduce the workforce the casinos and cause many
10 of us to be laid off. One being that
11 computers, in today's world, has a way of doing
12 that. I don't care if you're at the post
13 office, the supermarket, wherever you are,
14 computers have a tendency of either taking the
15 job completely away or cutting it back.

16 I hope you would take time today to
17 listen to our -- thank you for listening to our
18 concerns. Thank you for letting us putting
19 this on record. And I appreciate your time for
20 this.

21 CHAIR LEVINSON: Thank you very much for
22 coming in.

23 MS. LOVULLO: Thank you.

24 CHAIR LEVINSON: Is there -- can I get a
25 copy of that pamphlet?

2 MS. LOVULLO: Sure. This one here?

3 Can I come forward?

4 CHAIR LEVINSON: Yes. You can. You
5 just got to go around the wires.

6 Just put it in my good hand. Thank you.

7 MS. LOVULLO: Sure. Thank you.

8 CHAIR LEVINSON: I appreciate it.

9 Anybody else from the public wish to be
10 heard?

11 (No response.)

12 CHAIR LEVINSON: Seeing none, can I have
13 a motion to adjourn?

14 VICE CHAIR HARRINGTON: So moved.

15 CHAIR LEVINSON: Second?

16 COMMISSIONER COOPER: I'll make a
17 second.

18 CHAIR LEVINSON: All those in favor?

19 (Ayes.)

20 CHAIR LEVINSON: Opposed?

21 (No response.)

22 CHAIR LEVINSON: Meeting adjourned.

23 Thank you very much.
